

Scholarship Facts

CSFP provides need-based scholarships to children living in Philadelphia who will be entering grades K-8th in the fall.



Parents must choose a school for their child(ren) to attend from CSFP's 160 school partners and enroll their child(ren) for the following school year.



Scholarships are four years in length for eligible children.



All scholarship recipients are selected at RANDOM by computerized lottery.



Scholarships are partial: the amount of financial assistance families receive is based upon household size and income.



Scholarships typically range between 25% and 75% of school tuition, up to a maximum scholarship award for School Year 2017 of \$2,700.



Once a family is selected from the lottery, up to three eligible children may receive scholarships.

Application Process

1. Apply online at www.csfpphiladelphia.org, or complete this form and mail it to:

2. Complete only one application per family and list all eligible children.
3. CSFP will email and mail selected families to notify them of their selection. In the event that you are not selected but want to be notified, you must include a self-addressed, stamped envelope with your application.

Deadline is March 1

Priority given to applications received by November 15

Eligibility

CSFP encourages all eligible families to apply. CSFP requires:

1. Families reside within the City of Philadelphia.
2. Families' household income must fall within the Income Eligibility chart below.
3. Students must be entering grades K-8th in the fall of 2017.

If your family currently receives a CSFP scholarship, please contact CSFP before re-applying.
